The Board of Education of the Jefferson Elementary School District is seeking qualified, interested individuals to serve on a committee of community leaders which will serve as the independent Citizens' Oversight Committee ("COC") for the implementation of the District's Measure J school facilities bond program and Measure T Parcel Tax.

Proposition 39 Bond Election

On June 7, 2022, voters residing within the Jefferson Elementary School District passed Measure J. Measure J is a \$45 million bond measure that authorizes funding for needed repairs, upgrades, and new construction projects to the District's schools. Proposition 39 required a 55% supermajority for approval; Measure J was passed by 62.5%

Measure T Parcel Tax Election

On November 8, 2016, voters residing within Jefferson Elementary School District passed Measure T, Parcel tax in the amount of \$68 per parcel annually for 9 years.

Establishment of a Citizens' Oversight Committee

After a bond authorized under Proposition 39 is passed, state law requires that the Jefferson Elementary School District Board of Education appoint a Citizens' Oversight Committee to work with the District.

Committee Responsibilities

In accordance with Education Code Section 15278(b), the Citizens' Oversight Committee shall:

- Inform the public concerning the district's expenditure of Measure J bond and Measure T Parcel Tax proceeds;
- Review expenditure reports produced by the District to ensure that Measure J bond & Measure T Parcel Tax proceeds were expended only for the purposes set forth in Measure J; and Measure T;
- Present to the Board of Education in public session, an annual report outlining their activities and conclusions regarding the expenditure of Measure J bond & Measure T Parcel Tax proceeds.

The Bylaws which govern the Citizens' Oversight Committee are attached to this application.

Appointment of Committee Members

All appointment will be made by the Board of Education from applications submitted to the District.

Time Commitment and Term

Initial appointments will be staggered, such that some of the initial appointees will be appointed to serve one full two-year term. The other initial appointments will serve one-year term, but will be eligible for reappointment by the Board of Education for a second two-year term.
